





Originally from New Zealand where he earned his first degree from the University of Auckland, Brewer is currently a doctoral student at Virginia Tech University.



Dr. Shaffer is the editor of Deliberative Pedaaoav: Teaching and Learning for Democratic Engagement (Michigan State University Press, 2017), Jumping in to Civic Life: Stories of Public Work from Extension Professionals (Kettering Foundation Press, 2018), Agri-Culture and Future of Farming: An Interactivity Foundation Discussion Guidebook (Interactivity Foundation, 2018), A Crisis of Civility? Political Discourse and Its Discontents (Routledge, 2019) and Creating Space for Democracy: A Primer on Dialogue and Deliberation in Higher Education (Stylus, 2019). He has published dozens of articles and book chapters in academic publications; presents and engages diverse public audiences through radio, TV and print; and offers workshops and training to professionals in universities, non-profit organizations, government agencies and with legislative bodies.



Connected to these efforts, Dr. Shaffer serves as the associate editor of the Journal of Public Deliberation and as a country expert on deliberative democracy in the United States with the Varieties of Democracy project based at the University of Gothenburg. He received his B.A. from St. Bonaventure University, M.A. and M.P.A. from the University of Dayton and his Ph.D. from Cornell University.


