#### ED RELEASES BACK-TO-SCHOOL CHECKLIST FOR PARENTS

On Thursday, August 25, the Department of Education (ED) released a back-to-school [checklist](#) for parents and families to help caregivers engage with local school and district leaders about how they are supporting students as they recover from the impacts of the pandemic. “This checklist elevates key evidence-based practices for supporting students’ learning and mental health, and ensuring the safety of students and staff, which districts are encouraged to implement using American Rescue Plan (ARP) and other COVID relief funds,” ED’s [press release](#) says. In addition, the back-to-school ARP checklist also recognizes 15 examples of how states and school districts across the country are using ARP funds to support students and to staff schools. #### ED ANNOUNCES TARGETED STUDENT DEBT CANCELLATION

On Wednesday, August 24, the Department of Education (ED) [announced](#) that it will provide targeted student debt cancellation to borrowers with loans held by ED. Borrowers with annual income during the pandemic of under \$125,000 (for individuals) or under \$250,000 (for married couples or heads of households) who received a Pell Grant in college will be eligible for up to \$20,000 in debt cancellation, and non-Pell Grant recipient borrowers will be eligible for up to \$10,000 in relief. ED also announced a final extension of the pause on student loan repayment, interest, and collections through December 31, 2022. Additionally, ED is proposing long-term changes to the [Public Service Loan Forgiveness](#) (PSLF) program that will make it easier for borrowers working in public service to gain loan forgiveness. *Education Week* [reported](#) on how

the Administration’s student loan forgiveness plan and its changes to the PSLF program might benefit K-12 educators that borrowed to fund their university-based training. The article cites a National Education Association [report](#) that found 53 percent of the pre-K–12 teachers and specialized instructional support personnel that were surveyed took out student loans to fund their education.

The Hunt Institute recently published a research brief titled “Measuring Educational Opportunity in North Carolina Public School Districts,” which examines data on the reading and math achievement of students in North Carolina public schools as they progress from third to eighth grade. The analysis indicates that average achievement may reflect a broad range of educational opportunities available to students based on the socioeconomic status of the community where their school district is located, while achievement growth may better measure the unique contribution of schools toward promoting student learning and achievement.
