### 1. COSSBA Policy Priorities CHILD NUTRITION

<u>Healthy School Meals Should Be Available To All U.S. Students – Permanently</u> *The Hill* (September 7, 2022)

Roy Steiner, senior vice president of Food Initiatives at The Rockefeller Foundation, discusses the extension of the USDA's pandemic-era free meal waivers and implores Congress to stop passing months-long extensions and make healthy school meals available to all students permanently. "Federal leaders should be following the example set by California, Maine, Massachusetts, Nevada and Vermont in adopting policies that deliver healthy school meals not only to the relief of students and their families, but to school districts and other community programs which are often tasked with helping to catch those students who fall through the cracks after not qualifying for reduced meals, but who continue to arrive at and depart from school hungry," Steiner writes.

# 2. Budget and Appropriations Wrap-Up

Congress slowly resumed their Washington work this past week with the Senate returning and the House enjoying an extended recess for one more week. Their return was on the heels of an August that saw the passage of the **Inflation Reduction Act** and President Joe Biden announcing the cancellation/forgiveness of up to \$10,000 for federal student loan borrowers with incomes less than \$125,000 or from households with less than \$250,000, with an additional \$10,000 (total of up to \$20,000) for Pell Grant recipients. The President also continued the moratorium on payments for federal student loans and interest accrual until the end of the year.

The cancellation/forgiveness action has resulted in mixed reactions among Democrats and strong opposition from Republicans. Coupled with passage and subsequent signing into law of the Inflation Reduction Act, passed using the budget reconciliation process, the fall is going to bring

more partisanship as we approach the mid-term elections. However, as we move into September, Congress is also faced with the looming September 30<sup>th</sup> end of the federal fiscal year.

Discussion on a continuing resolution (CR) began shortly after Congress adjourned for recess with a target funding date of mid-December. A CR is a temporary funding measure that Congress will use to fund the federal government for a limited amount of time if Fiscal Year (FY) 2023 appropriations are not passed before the FY 2022 ends on September 30. As leaders in both Chambers continue to discuss the CR, various dynamics are emerging that may not lead to a quick and easy process. The White House has submitted a request for an additional \$47 billion to provide more assistance in Ukraine, for COVID-19 and monkeypox needs, and help with various natural disasters. During negotiations on the Inflation Reduction Act, Senator Joe Manchin (D-WV) secured a commitment to reduce the time on domestic energy permit efforts, which Senator Chuck Schumer (D-NY) has indicated he will attach to the CR. Republicans are bristling at providing additional COVID-19 funding, as they feel there are still sufficient unspent funds available. Progressive Democrats have signaled they will not vote for the CR if the permitting provision is included. Senator Bernie Sanders (I-VT) publicly announced his intention not to vote, which was followed a day later with a letter by 72 House Democrats stating the same. Resolving these issues will take up most of the air in Washington for the remainder of the month.

#### How does this impact State School Board Associations?

President Biden's federal loan forgiveness announcement included a proposal for long-term changes to the **Public Service Loan Forgiveness** (PSLF) program that will make it easier for borrowers working in public service to gain loan forgiveness. Changes to the PSLF program might benefit K-12 educators that borrowed to fund their university-based training.

Finally, the 2023 appropriations process, including the eventual CR, will ultimately determine how much money is allocated for the Department of Education and the programs that provide critical support at the district and school level. If a CR is passed through mid-December, the Department of Education will be funded at 2022 levels until 2023 spending bills are passed.

Later in the week, Second Gentleman Emhoff will join Secretary Cardona in Pennsylvania with visits that highlight how community schools are helping students recover academically and get the mental health supports they need, celebrate Hispanic Heritage Month, and raise awareness about the Administration's actions to provide debt relief to millions, including teachers and administrators through Public Service Loan Forgiveness. The Road to Success Bus Tour will feature stops in Tennessee, North Carolina, Virginia, West Virginia, Pennsylvania, and New Jersey.
