# 1. COSSBA Policy Priorities

#### **FUNDING**

## STATES RECEIVE FUNDING FOR 21ST CENTURY COMMUNITY LEARNING CENTERS

On Thursday, October 28, the Department of Education (ED) announced in a memo that states will begin receiving funding from the Bipartisan Safer Communities Act (BSCA) for the Nita M. Lowey 21st Century Community Learning Centers (21st CCLC) program. The BSCA appropriated a total of \$50 million for the 21st CCLC, an evidenced-based out-of-school time program that helps improve school climate by creating safe environments. A new report from the Center for American Progress titled, "How To Make Schools Safer Without Additional Physical Security Measures," notes that the new funding for the 21st CCLC program "specifically supports out-of-school learning time, such as afterschool, before-school, and summer learning experiences for students and communities," and that a number of stakeholders are eligible for the funding, including community-based organizations, nonprofits, faith-based initiatives, state afterschool networks, and local education agencies. ED's memo urges 21st CCLC subgrantees "to focus on grade-level appropriate practices supported by high-quality research" and lists examples of how the funds should be used, such as creating a welcoming, safe and inclusive environment; supporting family engagement and providing family supports; promoting strong connections between schools and 21st CCLC programs; implementing trauma-informed practices; establishing mentoring programs; and providing relevant and engaging learning experiences.

# 2. Budget and Appropriations Wrap-Up

Election Day is tomorrow, and, if polls are to be trusted, it looks like the 118<sup>th</sup> Congress will have Republicans in charge in the House. They could be leading the Senate, too. Of course, the last few election cycles suggest that polls aren't always accurate, and there are evolving factors that could affect predictions, but Democrats are understandably nervous.

If Republicans take charge of the House and Senate in January, Democrats will likely try to maximize the last few weeks of the 117<sup>th</sup> Congress. In recent days, there has been talk of using a **reconciliation** package to address the quick approaching debt limit for the Federal Government.

Such a strategy would arguably take the issue off the table before a change in leadership so that Republicans cannot use a "must-pass" debt ceiling increase as leverage to force votes on spending cuts. Raising the debt limit now would eliminate that leverage. A Republican-controlled House and Senate will be eager to develop their own reconciliation package in 2023 that would likely focus on spending cuts; they would like a bill to hit President Biden's desk and force him to decide whether to sign or veto such a measure.

The Fiscal Year (FY) 2023 spending bills remain outstanding, and it remains to be seen what might happen if both chambers flip. The current continuing resolution will expire in mid-December. While it was assumed Republicans would want to delay action on spending so that they might propose a smaller package early next year, Senate Minority Leader Mitch McConnell (R-KY) has recently suggested he'd like to be done with FY 2023 before the new Congress. Education advocates and others would much prefer to see an FY 2023 spending package that includes the increases proposed in the House Labor, Health and Human Services, and Education spending bill, which are higher than those developed by the Senate. Although either plan would almost certainly include higher spending levels for education than one developed by a Republican controlled Congress. The next few weeks will portend what might be possible.

# **How does this impact State School Board Associations?**

The outcome of the November elections will ultimately determine the policy and fiscal agenda for Congress beginning in 2023 and could determine whether an FY 23 omnibus funding bill is passed in the lame duck session beginning after tomorrow's elections. If the House switches to Republican leadership, and an omnibus spending package is pushed into the New Year, it is possible Republicans could cut domestic spending, including federal funding for schools and education programs. The debt ceiling fight could also lead to caps on federal discretionary spending, similar to those implemented in 2011, which could have serious effects on overall spending for education programs.

# 3. In Brief – Last Week in Washington EXPERT PANEL EXAMINES ACCESS TO STEM EDUCATION AND OPPORTUNITIES

On Tuesday, November 1, The *Washington Post* hosted a webinar titled, "Expanding Access to STEM Education and Opportunities." The event featured Sandra Cauffman, deputy director of Astrophysics; Lu Duong, director of the United Negro College Fund's Fund II Foundation STEM Scholars program; Nicol Turner Lee, director of the Center for Technology Innovation at the Brookings Institution; Valerie Sheares Ashby, president of the University of Maryland, Baltimore County; Beth McQuiston, neurologist & medical director at Abbott; Jo Webber, CEO of STEMconnector; and Jomi Babatunde-Omoya, a STEM Intern at Abbott. Lee began the event by pointing to the disparities that largely impacted low-income households and people of color during the pandemic, underscoring a lack of technological resources and exposure to school and community mentors. "Closing this divide is an issue of national and global competitiveness for the United States," she explained. Lee voiced support for the development of a national mentorship ecosystem where students of color are exposed to professionals that resemble themselves and share similar experiences. Duong expressed a similar sentiment, stating, "What we know in lower-income areas is that students don't have the access points to develop healthy, positive relationships with aspirational role models in STEM that look like them and come from

their own communities." He highlighted the "systemic boundaries" that exist around STEM education, noting that lower-income areas are less likely to offer advanced mathematics and science courses, setting students back academically. Minority students that are provided with less educational resources and opportunities drop out of college within the first two years at higher rates than their peers, Duong further explained. He also expressed a need for greater investment in Historically Black Colleges and Universities. Webber highlighted the benefits of hands-on learning exposure, while Ashby noted the crucial need for more inclusion and diversity at STEM institutions. "I need everybody, every institution to really support a diverse group of students in STEM. That is necessary," Ashby stated. She added, "Diversity equals excellence."
