2. Budget and Appropriations Wrap-Up

Last week, those elected to serve in the House and Senate for the 118th Congress came to Washington, DC, to be sworn in, get organized, and start the business of advancing the interests of the country. In the Senate, that went as planned. Not so for the House.

As of Friday afternoon, Members-elect of the House of Representatives had voted 13 times to try to select a Speaker of the House, with no success. Representative Kevin McCarthy (R-CA) had the support of most Republicans, but a group of about 20 refused to vote for him all week. The Democratic leader and nominee, Representative Hakeem Jeffries (D-NY), won unanimous support from his Democratic colleagues in every vote. The House reconvened at 10pm Friday night for the 14th vote, and by early Saturday morning, Representative McCarthy finally secured the Speaker's gavel on the 15th ballot with 216 votes. House lawmakers took their oaths of office early Saturday morning, shortly after the successful vote for Speaker.

The holdups to officially confirm a Speaker of the House came from a number of demands from the group of dissenters regarding the ability to pursue a “[motion to vacate](#)” – which allows for a vote to remove the Speaker, committee assignments, and procedural rules, among other issues. Before the negotiations for votes began, Republicans had proposed a package of rules changes that would change the way legislation moves through the chamber. The final rules package following McCarthy's election to Speaker is [here](#).

Now that Speaker McCarthy has finally been elected, Congress can get organized this week following passage of the House rules package, and advocates can get to advocating.

How does this impact State School Board Associations?

The effects of the inability to seat a Speaker last week were many. Those elected to the House—first-termers and returners—could not be sworn in, and were technically still Representatives-elect through Saturday morning. In addition, committees and their staff are not organized due to this delay. Education advocates still don't know who will be leading the House education committee panel, since Representative Tim Walberg (R-MI) said he intends to challenge Representative Virginia Foxx (R-NC) for the post. (It remains to see if last week's events affect those plans).

Also of note for the education community, Representative Andy Harris (R-MD), a member of the Freedom Caucus and one of the 20 Republicans hesitant to support a Speaker McCarthy until Friday, reportedly wants to chair the House Labor, Health and Human Services, and Education Appropriations Subcommittee. (Representative Tom Cole (R-OK) was the Ranking Member of

the panel, but if he becomes Chairman of the Rules Committee, he will likely give up that position.) A Chairman Harris would arguably make the education community's work more difficult in fighting for robust funding for education in appropriations debates.
