#### **FUNDING**

#### ED. HHS TAKE ACTION TO COMMENORATE MENTAL HEALTH AWARENESS MONTH

Acknowledging Mental Health Awareness Month, the Department of Education (ED) on Monday announced more than \$95 million in Bipartisan Safer Communities Act (BSCA) awards

to increase access to school-based mental health services and strengthen the pipeline of mental health professionals in schools. According to the announcement, the awards will help advance the Administration's efforts to tackle the mental health crisis in schools across the country as part of President Joe Biden's National Mental Health Strategy. The funding is being provided through two grants: The School Based Mental Health Services Grant Program (SBMH) and the Mental Health Services Professional Demonstration Grant Program (MHSP). Coinciding with this announcement, ED held a webinar that highlighted how these grant funds have been invested so far. The event featured opening remarks from Office of Special Education and Rehabilitative Services (OSERS) Acting Assistant Secretary Katherine Neas and several mental health and well-being professionals from academic institutions and local and state governments. The event accented the crucial role that comprehensive school-based mental health programs play in recruiting and retaining mental health professionals and supporting students' social and emotional well-being. The panel also provided best practices for establishing high quality, school-based mental health systems that promote positive learning environments. Meanwhile, on Thursday, the ED and the Department of Health and Human Services (HHS) announced updated resources and proposed regulations for schools to deliver health care to eligible students, with a focus on strengthening mental health services. Thursday's announcement included three actions the ED and HHS will take to also support Biden's national mental health strategy. Those actions include a Notice of Proposed Rulemaking under the Individuals with Disabilities Education Act (IDEA) that would streamline consent provisions when billing for Medicaid services provided through a student's individualized education program (IEP); a comprehensive guide for Medicaid school-based services to make it easier for schools to deliver and receive payment for health care services to eligible students; and the approval of state plan amendments for both New Mexico and Oregon that will allow Medicaid to pay for health care services schools delivered to more of their Medicaid-enrolled students. #### **BROADBAND CONNECTIVITY AND E-RATE**

#### SENATE PANEL EXAMINES RURAL BROADBAND, CONNECTING COMMUNITIES

On Wednesday, May 17, the Senate Agriculture, Nutrition and Forestry Rural Development and Energy Subcommittee held a hearing on "Rural Broadband: Connecting our Communities to the Digital Economy." The witness list included several telecommunications company representatives that shared their knowledge and experience and helped assess the Department of Agriculture's various broadband programs. Members of the Subcommittee delved into the disparities between rural and urban broadband service, and Subcommittee Chairman Peter Welch (D-VT) announced the introduction of a new bipartisan bill to improve the USDA ReConnect Loan and Grant Program. During his opening remarks, Welch stated, "Our overall job is to revitalize rural America and the health of rural America, we believe it is vital to the health as a nation." He further stated that because of the digital divide, "our kids are really limited in their educational opportunities." The National Education Association (NEA) also submitted written comment for the record, which outlined 10 policies and practices that Congress should consider to move toward digital equity for educators and students. "The NEA believes that the fallout from the COVID-19 pandemic has made it impossible to ignore the nation's digital divide and its repercussions on the rural communities, communities of color, and under-resourced communities it affects, and the association strongly supports efforts to ensure that every community in America has access to affordable, reliable, high-speed internet service," NEA said in its

#### **CHILD NUTRITION**

## PUBLIC FEEDBACK SPLIT ON USDA'S STRICTER SCHOOL NUTRITION PROPOSAL K-12 Dive (May 18, 2023)

The Department of Agriculture (USDA) received over 136,000 public comments on its proposed rule to revise school nutrition standards on whole grains, sugar and sodium following the federal agency's May 10 deadline for submissions. *K-12 Dive* reports that the comments were generally split among those who voiced support for the stricter standards because they would make school meals healthier and opponents who said the proposed changes would hurt student participation in school meal programs.

#### 2. Budget and Appropriations Wrap-Up

Until last Friday, it had been reported that negotiations between Congressional leadership and the White House on how to address the country's debt ceiling were going well. President Joe Biden canceled a number of international meetings to get back to Washington, DC, and the discussions. Then, on Friday afternoon, it was reported that negotiations hit a "pause." In talking to reporters, House Speaker Kevin McCarthy (R-CA) blamed the break on the White House and their resistance to spending cuts. Republicans are looking for cuts that total \$130 billion; Democrats find that figure unpalatable. The news was somewhat deflating—to observers and markets—after Thursday's optimism that a deal could be brokered and on the House floor this week. The House is in session this week while the Senate gets a jump on a Memorial Day Recess; the Senate is expected to return the week of May 29<sup>th</sup> while the House leaves Friday and is back in session on June 6<sup>th</sup>. Members of both chambers are on alert to return to Capitol Hill at any time throughout the planned breaks, but a number of Members are supposed to travel internationally and want to wrap up action on the debt limit before they leave. Perhaps it won't come to calling lawmakers back, though, as some involved in the talks are suggesting that the pause is a ploy to convey the urgency of the matter at hand and get everyone back to the table.

In the meantime, the House Appropriations Committee has begun action on spending bills. The panel released, and subcommittees passed, its first four FY 2024 appropriations bills. Two bills – Military Construction-Veterans Affairs, and Homeland Security – have greater funding than the FY 2023 level while the other two – Agriculture and Legislative Branch – propose funding cuts. The bill House Republicans passed to increase the debt ceiling also set total appropriations for FY 2024 at FY 2022 levels. That means that funding for the remaining eight government funding bills will be even lower than FY 2023 levels—and, as a reminder, Republicans intend to increase defense funding.

### How does this impact State School Board Associations?

Regarding appropriations, there are a lot of open questions on the process and funding levels. For example, if a would-be deal on the debt limit approves spending levels higher than the House Republican-backed bill, there could be more funds available for bills. The Labor, Health and Human Services and Education spending plan will surely be one of—if not the—last bills marked up, and will only be allocated what is left after the other bills are approved. Depending on the level, that could be devastating for education investments. It's worth noting, however, in

meetings with Democratic staff on Capitol Hill, advocates were assured that whatever the House does with education spending, it will not be the final level and what is enacted. The Senate will not stand for deep cuts to the programs, nor will the White House. Regardless, a year-long continuing resolution with some kind of across-the-board cut is still a strong contender for a final solution sometime later this year. There will be much drama to report on before any final solution. On the potential of a debt ceiling breach, *EducationWeek* dove into what it could mean for schools, saying, "If a default happens before July 1, the federal government might be unable to distribute billions of dollars for high-need students, special education services, and Englishlanguage instruction. Because school districts—many of which have already set their budgets for the coming year—count on those funds, teacher layoffs, academic program cuts, and administrative chaos could ensue." # 3. In Brief – Last Week in Washington OFFICE OF EDTECH HOLDS LISTENING SESSION ON EVIDENCE-BUILDING

On Monday, May 15, the Department of Education's (ED) Office of Educational Technology (OET) and Digital Promise held a listening session on cultivating partnerships to support edtech evidence building activities in schools. The listening session featured a panel of educational leaders, practitioners, developers, and researchers that provided real-world examples of partnership work that led to evidence building in schools and the benefits and challenges of that work; best practices for educational organizations working to secure partnerships; and ideas on how ED can support organizations advancing this work. The webinar opened with remarks from OET Deputy Director Kristina Ishmael, where she explained how schools should be active participants in using evidence to inform adoption decisions concerning technology in schools and articulated OET's role in providing schools with resources and guidance that support evidencebuilding efforts. OET Impact Fellow Dr. Yenda Prado and Digital Promise Senior Research Scientist Dr. Pati Ruiz followed Ishmael, setting the stage for a discussion on specific challenges schools and districts face when working to establish whether the education technology they use is evidence-based, which listeners were able to respond to. The listening session also included a discussion panel with participation from Dr. Matt Soldner, NCEE commissioner for the Institute of Education Sciences at the ED; Erin Mote, InnovateEDU executive director and cofounder; Monique Daviss, El Sol Sciences and Art Academy of Santa Ana executive director; Sunil Gunderia, Age of Learning chief innovation officer; and Dr. Ying Xu, assistant professor for the Marsal Family School of Education at the University of Michigan. The panel highlighted OET's EdTech Evidence Toolkit as a resource schools can use to partner with local and state leadership, developers and researchers in evidence-building. The toolkit offers educational leaders support in using evidence to inform edtech adoption decisions in schools by providing introductory evidence-building activities for four tiers of evidence, as outlined in the Elementary and Secondary Education Act (ESEA); example case studies for using evidence-building activities to inform edtech adoption; and suggestions for collaborative activities to encourage use of evidence in schools. Throughout the session, listeners were able to respond to poll questions that would propel panel discussion on the topic. More information can be found here.

#### HOUSE PANEL QUESTIONS CARDONA ON ED POLICY AND PRIORITIES

On Tuesday, May 16, the House Education and the Workforce Committee hosted a hearing titled, "Examining the Policies and Priorities of the Department of Education." The hearing

featured a single witness—Secretary of Education Miguel Cardona. During the proceeding, the Secretary faced queries on many familiar and topical education issues. The hearing made clear that Committee Chair Virginia Foxx (R-NC) and her Republican colleagues would like more responsiveness from the agency in their oversight efforts and that there is tremendous concern from them about the Department's Title IX proposed guidance. In her opening remarks, Foxx cited the Committee's "primary duty" of oversight and referred to 11 oversight letters she has directed to the Department of Education (ED) this year and what she considers to be the agency's "disingenuous and misleading actions while being minimally responsive to congressional oversight." In contrast, panel Democrats were largely supportive of the agency and the budget plan and used the hearing as an opportunity to warn of the effects of House Republican-proposed budget cuts. Ranking Member Bobby Scott (D-VA) specifically complimented the Agency's efforts to address student loan programs, including relief efforts, forgiveness for public sector workers and income-driven repayment options. He additionally complimented the White House's FY 2024 budget request, including efforts to buoy career and technical education, significantly increase funds for the country's poorest schools, more funds for the Individuals with Disabilities Education Act (IDEA), bigger Pell Grants and other proposals, saying, "When we invest in education, students can succeed." There were concerns from both sides of the aisle as ED prepares to restart collection of federal student loan payments this year, given bad experiences with third party servicers of student loan programs in the past. #### ED RELEASES SCHOOL DIVERSITY REPORT, ANNOUNCES NEW GRANT PROGRAM

On Friday, May 19, to commemorate the 69th anniversary of the Brown v. Board of Education Supreme Court ruling, the Department of Education (ED) released a new report on the state of diversity within America's schools, which finds that progress toward increased racial and socioeconomic diversity has stalled in many communities, leading to inequitable access and outcomes for students. "Diverse schools benefit all students, helping to foster performance and success through improved academic achievement, social mobility, civic engagement, empathy, and understanding," ED said in its press release. The Department also released a Notice Inviting Applications (NIA) for the newly established Fostering Diverse Schools Demonstration **Program**, which will fund \$10 million in awards to local and state agencies to implement plans to increase diversity in schools. "Nearly 70 years after the Brown v. Board decision declared segregation in our public schools unconstitutional, we cannot ignore the powerful role that race, place, and income continue to play in access to educational opportunity in America," said Secretary of Education Miguel Cardona. "At a time when some are trying to turn 'equity' into a bad word, we must recognize that the racial and socioeconomic isolation that persists in our public schools undermines our national competitiveness by denying students of all backgrounds the rich educational experiences that result from diverse learning environments," the Secretary continued.
