# TEACHER-PRINCIPAL TRAINING & RECRUITMENT ED AWARDS NEARLY \$115M TO INCREASE EDUCATOR PAY, PROMOTE DIVERSITY

The Department of Education (ED) announced last week nearly \$115 million in new awards to support 29 Teacher and School Leader (TSL) Incentive projects, which expand on ED's efforts to ensure a well-prepared, diverse, and sustainable educator workforce. Through Raise the Bar:

Lead the World, ED is supporting states and school districts in their efforts to eliminate educator shortages. The TSL grants help districts to address educator shortages by supporting career advancement and teacher leadership opportunities, increasing compensation, and improving educator retention. "While all students benefit from diverse teachers, when students of color see their backgrounds and experiences reflected in their teachers, we see higher levels of academic achievement and student engagement in school, and more students aspiring to be teachers themselves one day. That's why attracting, retaining, and supporting a diverse educator workforce is a top priority in our efforts to Raise the Bar for learning conditions in our schools."

# 2. Budget and Appropriations Wrap-Up

Last week, the House's new Speaker, Representative Mike Johnson (R-LA) started working on many tasks associated with the position. He started hiring for the staff needed for a Speaker's team, held his first press conference, and met with his counterparts. He also started shepherding a number of spending bills through the House, <u>including one that would send aid to Israel</u> via offsets in the IRS's budget. The House has passed half of the 12 Fiscal Year (FY) 2024 spending bills (the Senate has passed three), but Speaker Johnson is also discussing what he might like to see in a continuing resolution (CR) to fund the government past November 17<sup>th</sup>—the expiration date of the measure keeping the government open now. He has floated the idea of a bill that would fund operations through January 15<sup>th</sup>, although <u>some other novel scenarios have also been discussed</u>, including funding some pieces of the government longer than others.

Speaker Johnson's approach to the Israel aid bill has its critics on both sides of the aisle, which could make efforts to get any legislation to President Biden's desk difficult. Senate Majority Leader Chuck Schumer (D-NY) and Minority Leader Mitch McConnell (R-KY) have criticized the House-passed Israel aid bill, <u>although for different reasons</u>.

Advocates will certainly focus on appropriations once again this week. Everyone is watching the calendar as November 17<sup>th</sup> and another potential shutdown approaches.

# How does this impact State School Board Associations?

COSSBA's federal relations team in D.C. is closely monitoring action on the FY 2024 Labor, Health and Human Services and Education spending bill on both sides of the Capitol. Speaker Johnson has said the bill, which proposes devastating cuts to education investments, could be on the floor the week of November 13 – though that looks less and less likely. Members of the House were given a deadline of last Friday to propose additional <u>amendments</u> to the bill. The Commerce, Justice and Science bill, which would fund some juvenile programs at the Justice Department at troubling levels and cut STEM education funding at the National Science Foundation, could be on the House floor as early as next week. Advocates continue to press lawmakers to reject both House proposals—which only have Republican support—in favor of the bipartisan Senate bills.

# WHITE HOUSE ISSUES EXECUTIVE ORDER ON AI. INCLUDES EDUCATION PROVISIONS

On Monday, President Joe Biden issued an Executive Order (EO) on safe, secure, and trustworthy Artificial Intelligence (AI). The EO released on Monday builds off of the <a href="White">White</a> House 2022 AI Bill of Rights and establishes new standards for AI safety and security, protects Americans' privacy, advances equity and civil rights, stands up for consumers and workers, promotes innovation and competition, advances American leadership around the world, and more. Pertaining to education, the EO requires three main things from the Department of Education (ED) within 365 days of the date of the order: the development of resources, policies,

and guidance regarding AI; the development of an "AI toolkit" for education leaders; and the strengthening and expanding of education and training opportunities that provide individual pathways to occupations related to AI. The resources developed by the Secretary of Education, in accordance with the EO, will address safe, responsible, and nondiscriminatory uses of AI in education, including the impact AI systems have on vulnerable and underserved communities. The EO states that the "AI toolkit" should assist with implementing recommendations from the ED's AI and the Future of Teaching and Learning report, including appropriate human review of AI decisions, designing AI systems to enhance trust and safety and align with privacy-related laws and regulations in the educational context, and developing education-specific guardrails. Additionally, to address AI-enabled deception, the EO establishes standards and best practices for detecting AI-generated content (through watermarking) and authenticating official content which could help address educators' concerns that AI can help students plagiarize. #### EARLY LEARNING EXPERTS EXAMINE EARLY ELEMENTARY SCHOOL ENROLLMENT

On Monday, the Urban Institute hosted an event titled, "The Effects of Public Prekindergarten for 3-Year-Olds on Early Elementary School Enrollment." During the first half of the discussion, Breno Braga, principal research associate for the Urban Institute, presented data, methods, and findings from the Urban Institute's research on early enrollment utilizing evidence from the Washington, D.C. centralized lottery system known as My School DC. During the second half of the discussion, Erica Greenberg, principal research associate for the Urban Institute, moderated a discussion with guest speakers Miriam Calderón, chief policy officer of ZERO TO THREE; Pamela Morris-Perez, professor of applied biology at New York University Steinhardt School of Culture, Education, and Human Development; and Maurice Sykes, D.C. Early Learning Collaborative board member. Currently, six states and Washington, D.C. offer universal public Pre-K, but these programs are primarily focused on recruiting and retaining four-year-olds. D.C. is the exception, offering Pre-K for three-year-olds (Pre-K3), serving about 69 percent of the District's three-year-olds. Little research has been conducted on Pre-K3's impact, so the Urban Institute set out to fill this gap. Primary research questions looked at the relationship between school-based Pre-K3 students and the likelihood of those students to enroll in a public kindergarten program; to persist in the public school system; and the likelihood to switch public schools. Secondary research questions looked at the effectiveness of program models, such as dual language and Montessori, as well as the students that benefit the most from Pre-K3 based on racial, ethnic, and socioeconomic backgrounds. By looking at data from the D.C. lottery system, the Urban Institute found that participating in Pre-K3 increases kindergarten enrollment and persistence in the D.C. Public School (DCPS) system. The findings also show that children enrolled in a DCPS Pre-K3 program are 18.5 percent more likely to enroll in a DCPS kindergarten school and 37.2 percent more likely to persist in the DCPS system. During the panel discussion, panelists considered the report's implications on policy, practice, and research. Calderón pointed out that universal access does not mean universal quality, and more research should be done to address the quality of Pre-K3 programs. Morris-Perez was interested in looking at the post-pandemic enrollment challenge, especially for Pre-K3 to kindergarten students. Sykes acknowledged that the D.C. Pre-K3 system is hard to replicate in other areas of the country because every community has its own political, social, cultural, educational, and economic context. #### AEI ON EXPANDING EDUCATIONAL OPPORTUNITIES WITH GEOFFREY CANADA

On Monday, the American Enterprise Institute (AEI) hosted Geoffrey Canada, president of Harlem Children's Zone and founder of the William Julius Wilson Institute, for a discussion with AEI's Frederick M. Hess, director of education policy studies, on expanding educational opportunity through community-wide efforts and challenges presented by the current political landscape. Following an introduction by Dr. Hess, Canada provided remarks on the importance of education and "place-based theory," an instructive approach that prioritizes the connection between a learning process and the physical place in which teachers and students are located. Canada further illustrated present challenges in the education system and the struggles students and educators currently face, particularly related to increased violence and stressors on mental wellness. "It's too much for a school. You can't just put all this on a school and say, 'Okay now solve every problem in society," Hess explained. He spoke to how the Harlem Children's Zone addressed these problems, saying that the organization supported parents starting at the birth of their children by providing parents with information on brain and child development. This elevated level of support continued with the children through grade school, college and career development. "We're asking other folks to not walk away from education...but to simply say in certain places, putting all of this on a public school is unfair. There's no evidence that it will work at scale," said Hess. Hess and Canada then participated in a fireside chat, where they discussed more of Canada's work, how politics have impacted education over the years, and parental responsibility. The discussion highlighted the significant impact local communities can have on education and pressed the importance of creating a positive environment for students. Following the conversation, questions from the audience honed in on Canada's influence on education reform efforts across the country and education in the aftermath of the pandemic.
