COSSBA FEDERAL PRIORITIES

- Increase Federal Education Funding
- Teacher and Principal Training and Recruitment: Title II, Part A
- Individuals with Disabilities Education Act (IDEA)
- Child Nutrition Programs
- Broadband, Connectivity, Cyber-Security, & E-Rate
- Prioritizing Public K-12 Education as Schools of Choice



FEDERAL EDUCATION FUNDING

Significant increases in Title I funding to allow
schools to quickly address and overcome
achievement gaps and disparities exacerbated by
COVID-19.

• Increases in Title IV funding to help solve the additional student health challenges schools are facing, especially those in mental health.



TEACHERS AND PRINCIPALS

- Increase Title II, Part A funding to attract, develop, and retain high quality educators by including the Preparing and Retaining Education Professionals (PREP) Act in the Higher Education Act legislation.
- Incentivize teacher and principal licensure reform efforts with the goals of improving student achievement and meeting the needs of public schools.



IDEA

 Amend IDEA to ensure parents and school districts can fully collaborate and provide an education that meets the needs of individual students.

• Allocate more funding for students with disabilities that is at least equal to the national average per pupil expenditure for students served under the IDEA.



CHILD NUTRITION PROGRAMS

• Extend recently-expired reimbursement rate increases and nutrition waivers to ease supply chain and post-pandemic challenges.

- Provide funds to:
 - Cover higher food/labor costs
 - Increase lunch/breakfast reimbursements
 - Expand lunch/breakfast to offer free meals to all students

CHILD NUTRITION PROGRAMS

• Bolster National School Lunch Program/School Breakfast Program to include expansion of community eligibility so that more schools serving large numbers of low-income children can provide meals at no charge to all students, including creating a statewide option so that states could more easily begin offering meals at no charge to all students.





CHILD NUTRITION PROGRAMS

• Reduce burdensome federal mandates and provide flexibility for school districts to administer healthy meals students want to eat, to include reducing meal planning complexities, cutting red tape, and maximizing staff time and funds for meal prep.

• No unfunded mandates or under-resourced requirements.



BROADBAND, CONNECTIVITY, CYBERSECURITY & E-RATE

- Codify and fund federal support for implementing effective cybersecurity measures for K-12 schools.
- Distribute emergency funding for students who lack access to devices and/or connectivity.
- Implement a permanent exemption or solution to the Anti-Deficiency Act.
- Reinstate net neutrality to ensure that schools are paying additional costs.



PRIORITIZING K-12 PUBLIC EDUCATION

COSSBA opposes increased federal government ulletactivity and funding for non-public school choice options, including but not limited to voucher, tax credit, and Education Savings Account programs. These programs divert funding from public schools, lack financial transparency and accountability, and are subject to less regulation and oversight.

STATUS OF FY '24 APPROPRIATIONS

- House has cleared 7 bills
- Senate has passed 3 bills
- Fiscal Year '23 ended September 30th
- Passed Continuing Resolution (CR) to maintain current funding through Nov. 17
- Passed 2nd CR providing funding until Jan.
 19, 2024 or Feb. 2, 2024

 - Transportation
 - Housing and Urban Development
 - Energy
 - Military Construction
- <u>February 2, 2024:</u>
 - Everything else





STATUS OF FY '24 APPROPRIATIONS

• House Labor, HHS, and Education Bill

Cuts Title I funding by nearly 80%
\$14.7 billion

• Eliminates Title II-A funding (\$2 B)

• Eliminates ESL funding (\$890 M)
