

GENDER REPORTING REQUIREMENT HOUSE BILL 4624

(EFFECTIVE MAY 21, 2024)

PROHIBITS
ENCOURAGING,
COERCING
TRANSGENDER STUDENT
FROM WITHHOLDING
FACT FROM PARENTS

PROHIBITS WITHHOLDING TRANSGENDER STUDENT'S PERCEPTION FROM PARENT

PRINCIPAL, VICE
PRINCIPAL OR
COUNSELOR DIRECTED TO
NOTIFY PARENTS

ASSERTS TO STAFF HIS/HER
GENDER IS INCONSISTENT
ON BIRTH CERTIFICATE


Annually by August 1
Booster Clubs **must**REGISTER WITH DISTRICT BOARD


PRIMARY PURPOSE: RAISES \$\$

REGISTRATION = NAME OF CLUB AND PURPOSE, OFFICERS, INCLUDING FINANCIAL OFFICER

NO REGISTER? NO TRANSACTIONS

NO ONE CONVICTED OF FINANCIAL CRIME CAN SERVE AS FINANCIAL OFFICER BOARD MAY REQUEST STATE
CRIMINAL RECORDS CHECK
OF FINANCIAL OFFICER
MUST NOTIFY IF CHECK
REVEALS CONVICTION

FY 2024-2025 STATE APPROPRIATIONS HOUSE BILL 5100

- \$14 BILLION STATE BUDGET
- \$200 million State Aid to fund revised teacher salary schedule (estimated to cost \$198)
- SALARY INCREASES ARE NOT APPLIED
 UNIFORMLY ACROSS THE BOARD RANGE
 FROM \$5,694 INCREASE FOR TEACHERS WITH
 5 YEARS EXPERIENCE AND BACHELOR'S
 DEGREE TO \$100 INCREASE FOR A TEACHER
 WITH 7 YEARS OF EXPERIENCE WITH A
 DOCTORATE DEGREE
- STATE FUNDING ALLOCATED DIRECTLY FOR DISTRICTS ONLY FOR TEACHER COSTS


