All other SCSBA members are welcome to attend for \$150 per person, which includes lunch.

Gain practical skills to effectively lead and manage at SCSBA's annual leadership session specifically for experienced and new board chairs. Held from 8 a.m. to 3 p.m., the workshop focuses on the specific roles, responsibilities and skills needed to address the demanding issues associated with the top job. ## Anne Marie Anderson

*Author, three-time Emmy Award winning broadcaster and keynote speaker*

Anne Marie Anderson is a three-time Emmy Award winning broadcaster, keynote speaker and author. As she walked through ESPN's doors fresh out of college, Anne Marie embarked on a career that led her into the boardrooms and locker rooms of some of the most successful franchises in sport.

Utilizing the methods observed through behind-the-scenes access to high-performing coaches, athletes and executives, Anderson applied their penchant for taking bold and sometimes surprising risks to her own personal and professional life. The knowledge and experience she gained through making one unexpected career move after another led her to become one of the most experienced female play-by-play announcers in the country.

In "Cultivating Audacity," Anne Marie shares the system she developed to find the courage to confront hesitation and break down barriers that stood between her and the life she wanted. Anne Marie is known for delivering keynotes that are alternately funny and touching. She seeks to connect with audiences through the power of storytelling.

## Former Gov. David M. Beasley

*International Humanitarian, Peacemaker, Reformer*

David Beasley is a distinguished leader, humanitarian and former governor of South Carolina (1995–1999). He most recently served as the executive director of the United Nations World Food Programme (WFP) from 2017 to April 2023, having been nominated by two U.S. presidential administrations from different parties and appointed by the UN secretary-general.

Under Beasley's leadership, WFP became the largest humanitarian organization in the world, assisting more than 160 million people in 2022 alone and raising more than \$55 billion to combat global hunger. In 2020, he accepted the Nobel Peace Prize on behalf of WFP for his efforts to provide food assistance in conflict areas and prevent food from being used as a weapon of war.

In his Oslo acceptance speech on Dec. 10, 2021, he remarked:

"We have learned that there is great richness in those who are seen, in the eyes of the world, as 'the poor.' And many of us who are considered 'rich' are actually poor in the things that matter most."

Elizabeth "Liz" Huntley is an accomplished litigation attorney, dedicated child advocate, author and lecturer. Liz is the president and cofounder of the Hope Institute, an organization in Alabama that helps schools build a culture of character for students. She practices law at Lightfoot, Franklin & White LLC in Birmingham, Alabama.

Liz serves on multiple civic boards, commissions and task forces throughout Alabama and the country. She regularly speaks to groups across the U.S., often referencing her journey as described in her memoir, "More Than A Bird."

Liz earned her law degree from the University of Alabama School of Law, where she serves on the Law School Foundation Board of Governors. She received her undergraduate degree from Auburn University, where she is a member of the Auburn University Board of Trustees. Liz and her husband, Tony, live in Alabama and have three children.

## Ellen Weaver

*S.C. Superintendent of Education*

Born and raised in South Carolina, Ellen knows firsthand the sacrifices families make to give their children a brighter future.

Her own path—reading with her mom and great-grandmother, working alongside her dad on the construction site, graduating from an outstanding public school, and working for U.S. Senator Jim DeMint—taught her the power of faith, integrity, hard work, and standing firm for what you believe.

In 2013, Ellen founded Palmetto Promise Institute, to champion common sense, conservative solutions that expand opportunity for her fellow South Carolinians. She also served as the first female chair of the South Carolina Education Oversight Committee.

Today, as State Superintendent of Education, she has turned vision into action: implementing evidence-based reading instruction grounded in phonics, leading the charge for phone-free classrooms, investing in safe schools and buses, and partnering with parents to restore trust and transparency in education.

Ellen's guiding belief is simple: hope is not passive. It's an action plan. With a listening ear, a strong backbone, and a laser focus on excellence, she works each day to ensure every child graduates ready for college, career, or military service. When education rises, South Carolina rises.

## Dr. Shawn D. Foster

*Superintendent, Orangeburg County School District (2026 SCASA Superintendent of the Year)*

Dr. Shawn D. Foster is a distinguished educational leader and author of the inspirational leadership memoir "Knee Deep: Dying to Lead." With more than two decades of experience in school and district transformation, Dr. Foster serves as superintendent of Orangeburg County School District (OCSD), where he is committed to advancing academic excellence, equity and innovation.

Under Dr. Foster's leadership, OCSD has undergone significant transformation in instructional practices and student opportunities. He has championed initiatives to improve educational outcomes, ensuring that all students receive a rigorous and high-quality learning experience.

Notably, he led efforts to secure a \$190 million bond referendum, supplemented by an additional \$40 million investment and a 90-acre land donation to support new schools and modernized facilities. This visionary leadership has positioned OCSD as a member of the national League of Innovative Schools.

Dr. Foster influences statewide and national policy through service on the Executive Committee of the South Carolina Superintendents' Roundtable, the South Carolina High School League Executive Committee and the National Institute for Excellence in Teaching Advisory Board.

He is also a Riley Institute Diversity Fellow and a Racial Equity Leadership Network Fellow through the Southern Education Foundation. His work extends to healthcare partnership development as a member of the Advisory Board for MUSC Hospital Orangeburg.

Dr. Foster has received numerous honors, including recognition as the 2025 3A/2A/1A Superintendent of the Year by the South Carolina Athletic Administrators Association and 2026 South Carolina State Superintendent of the Year by the South Carolina Association of School Administrators.

## Corey Bedenbaugh

*Social Studies Teacher, Batesburg-Leesville Middle School, Lexington Three (2026 South Carolina Teacher of the Year)*

Corey Bedenbaugh, an eighth grade social studies teacher at Batesburg-Leesville Middle School, is a dedicated educator who believes great teachers do more than teach — they inspire.

Bedenbaugh, an 11-year teaching veteran, now serves as a statewide ambassador for the teaching profession, inspiring future educators and mentoring teachers across the state. Having taught at both Batesburg-Leesville Middle School in Lexington School District Three and Pelion Middle School, Bedenbaugh has demonstrated consistent commitment to shaping young minds.

He founded Bow Ties with Bedenbaugh, a mentorship club for young men, and he coaches the JV girls basketball team, promoting teamwork and resilience among student-athletes.
